RULES & REGULATIONS

EXHIBITOR PASSES, which permit exhibitors to enter the Show area without payment, are issued based on the amount of space purchased and must be picked –up and signed for during set-up days. Exhibitor passes are not collected but are shown only and can be used throughout the Show. Exhibitors can purchase complimentary passes at half-price to supplement the exhibitor passes. Entry to the Show area during non-Show hours is strictly prohibited. The buildings are kept locked and no one admitted without special permission from the Show Committee. All reasonable means are taken by the Exchange Club to protect the property of the exhibitors. However, all goods, wares, and merchandise of any kind placed in the Show is understood to be at the owner's risk and by acceptance of this contract, the Exchange Club is released of and from any and all claims, demands, suits, judgements, costs, attorney's fees, and other damages arising out of occurrences in or at the leased space or as occasioned or suffered by exhibitor or any of its employees, agents or persons in attendance in or such space. **EXHIBITORS ARE URGED TO USE CAUTION AND NOT LEAVE VALUABLES IN BOOTHS WHEN NOT ATTENDED AND DURING SET-UP AND TEAR DOWN.**

Exhibitors agree to install an attractive, educational display of its product or service. ALL INTERIOR WALLS IN A BOOTH MUST BE SUITABLY COVERED. DRAPES ARE PROVIDED BY THE SHOW COMMITTEE. Exposed walls to the aisle on end-booths must be covered by the exhibitor erecting those walls. Exhibitors along exterior walls must have those walls covered. The Committee reserves the right to prohibit an exhibit or part of an exhibit which, in their judgement, may detract from the character of the Show. This restriction includes persons, things, displays, conduct and printed matter. Subletting of exhibit space is prohibited. Two or more firms may not exhibit in a single space unless a special arrangement is made with the Show Committee. No exhibit will be permitted to protrude into adjoining booths or the aisles at either floor or 8' ceiling levels. No sign may be erected which block the visibility of another booth. All drawings for prizes and give-a-ways must be registered with the Show Committee in advance for approval. No exhibitor may advertise or distribute tickets for prizes or give-a-ways which are contingent upon a purchase, or conduct any promotions with obligations imposed. All prizes must be given away by 6 PM Saturday of the show.

ELECTRICAL SERVICE (110 volt 20 amp) is available for \$35.00 per exhibitor. **Special electrical needs are provided at the exhibitor's expense and must be requested using a form supplied by the Exchange Club.** This form must be received by the Exchange Club four weeks prior to exhibitor set-up. Exhibitors must share access to electrical outlets and are prohibited from blocking any access. Extension cords are the responsibility of the exhibitor and must be approved gauged to the size of the load according to N.E.C. All equipment regardless of source of power must comply with National Electrical Code, all Federal State and Local Safety Codes.

Accessories are **not** included in the cost of exhibit space and must be leased at the exhibitor's expense. These items can be leased through Advantage Conference & Expo at (410) 789-5000, Fax (410) 789-5564.

The exhibitor will be required to replace, repair or otherwise assume all expenses for any defacement or injury of the premises caused by their exhibit or its representative(s). All aisles must be kept clear. Exhibits, interviews, demonstrations, distribution of literature, etc. must be made **within the exhibitor's space only**. Booths must be able to pass Fire Marshal's inspection and for this reason non-flammable materials are recommended.

INSURANCE Exhibitors at their own expense shall have and maintain a commercial general liability policy that provides coverage against claims of personal injury, death or property damage occurring on the premises of the Show. Such policy shall afford protection with a limit of at least \$300,000, combined single limit. A certificate of insurance shall be included with your signed contract, naming The Exchange Club of Hanover, Builder's Home and Garden Show, PO Box 634, Hanover, PA 17331 as the certificate holder. Failure by the exhibitor to comply shall result in termination of this contract.

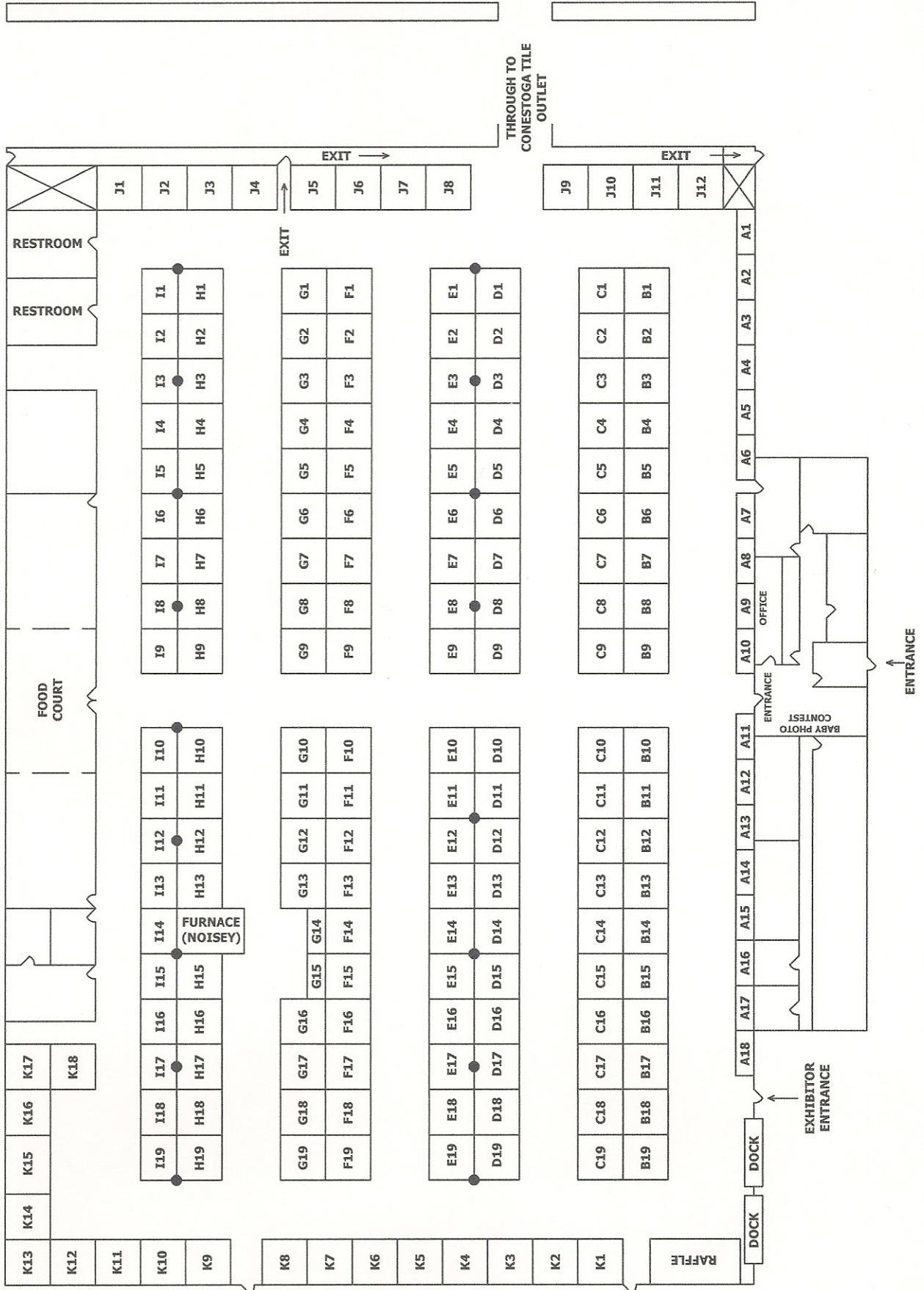
The Exchange Club shall not be required to perform any term, condition or covenant in this lease so long as such performance is delayed or prevented by any Acts of God, strikes, lockouts, material or labor restrictions by any governmental authority, civil riot, floods, or any other cause not reasonably within the control of the Exchange Club and which by the exercise of due diligence The Exchange Club is unable, wholly or in part to prevent or overcome.

All disputes arising from any cause whatsoever among exhibitors shall be adjusted by the Show Committee whose decision shall be final. All special requests by exhibitors shall be directed to the Show Committee. The Committee reserves the right to adopt and promulgate such further Rules and Regulations it deems necessary.

VIOLATIONS: Any exhibitor breaching or violating any of the above Rules and Regulations shall upon oral notification by the Show Committee forthwith comply with such Rules and Regulations. If oral warning is not heeded and violation of the terms and conditions of these regulations on the part of any exhibitor continues, right is hereby given the Exchange Club to terminate the lease to occupy space at its option, and the Exchange Club may re-enter and take possession of the space occupied by the exhibitor and remove all persons and goods at the exhibitor's own risk. And the exhibitor shall pay all expense in connection with such removal and all damages which the Exchange Club may incur, and forfeit all moneys paid or due to the Exchange Club on account thereof.
